# **TLC rules and regulations 2**

1. If a driver fails a drug test:

A WAV driver has 2 minutes to accept a dispatch from accessible dispatch (WAV base). A WAV driver who has accepted a dispatch from accessible dispatch must wait at least 10 minutes for the passenger.

#### Note:

TLC drivers a never allowed to give gifts or bribes to TLC employees, TLC officials, or any other public servant, airport or transportation terminal staff, dispatchers, airport information services, security services, traffic or parking attendants, baggage handlers.

# 10. "No Standing" indicates drivers can only:
